Mission

The Community Foundation of Switzerland County, Inc.'s (CFSCI) mission is: Connecting People Who Care With Causes That Matter For Good For Ever For Switzerland County. CFSCI's board and staff are dedicated to building, managing, and distributing a lasting source of charitable funds for the good of Switzerland County.

Assets

As of December 31, 2017, total net assets were approximately \$12.5 million.

Grants

Since its inception, the Community Foundation has granted out approximately \$3.2 million in direct grants and scholarships and has assisted in bringing an additional \$6.5 million into Switzerland County.

Governance

A volunteer Board of Directors made up from the different areas of the county govern the Community Foundation. In 2018, Dick Yanikoski was elected President of the Board. Past presidents include founding president John Keeton, Roger Nay, Judy Firth, Jill Hutcherson, Cindy Welch, Sandy Althoff, Roger Parrott, Adam Cole, Steve Lyons and Roy Leap.

Funding

CFSCI makes grants from over 100 different charitable funds that donors have established at the Foundation. Donors may ask the Foundation to grant their funds to a particular organization or field of interest, or they may prefer that grantmaking decisions be left to the discretion of the Foundation's Board of Directors. Nonprofit organizations can also create endowment funds at the Foundation to support their own missions.

Program Areas

CFSCI awards grants in the areas of community service, social service, education, health, environment, and arts & culture. At the request of the donor, grants may be made for religious purposes.

Area Served

Primarily Switzerland County, but grants may be made to organizations outside of Switzerland County who serve the needs of the Switzerland County community.

Tax Status

As a public charity, CFSCI offers donors the highest level of charitable tax benefits.

Security, flexibility, and tax advantages are key to all contributions to the Community Foundation. Our staff will guide you through the process of establishing a fund, or directing your gift to an existing fund that is best suited to your charitable desires. You can be assured your donation will be utilized according to your philanthropic interests. The variety of fund options and giving methods available to you will provide flexibility in accommodating your charitable goals and meeting your tax and estate planning objectives.

Cash: Gifts of cash enable you as a donor to claim a current tax deduction of up to 50% of your adjusted gross income in any one year when you itemize deductions, with the excess, if any, carried forward for an additional five years.

Securities: Gifts of appreciated securities offer important tax advantages, since their full fair market value is deductible as a charitable contribution up to 30% of your adjusted gross income each year when you itemize deductions. Like gifts of cash, deduction amounts that exceed the limit can be carried forward for up to five additional years. You do not have to pay federal or state capital gains taxes on the appreciated portion of the gift.

Real Estate: The Community Foundation can accept a gift of a house or other personal residence, farm, commercial building, and income-producing or non-income-producing land. A gift of real estate that you have owned for more than a year entitles you to a tax deduction based on the fair market value of the property - while allowing you to avoid capital gains tax. While this type of gift must be approved in advance, unencumbered real property is an excellent option.

Life Insurance: For those whose need for life insurance has decreased, making a gift of an unneeded policy can be a convenient and effective way of meeting your charitable goals. When you transfer ownership of a cash value policy to the Community Foundation, you become eligible for a charitable tax deduction based on its current value.

Retirement Plan Assets: For a gift through your estate, retirement plan assets are often the best to give because they are so heavily taxed if left to heirs. Income and estate taxes can easily consume over 65% of the account balance at death. By naming the Foundation as the remainder beneficiary of these assets, you can leave a very efficient legacy.

Bequest by Will: Naming the Foundation in your will or living trust is a popular way to support the community. Your estate receives a charitable deduction for the full amount given, so your heirs pay no estate tax. Sample bequest language may be obtained at the Community Foundation office.

Charitable Gift Annuity: Giving through a Charitable Gift Annuity allows you to arrange a generous gift to your community, while providing yourself (or a loved one) with a new income source you can count on for the rest of your life. We set up a contract with you that combines immediate annuity payments with a deferred charitable gift. You receive a stream of income that is fixed, regardless of market conditions. Upon your death, we set up a charitable fund on your behalf.

How is the Community Foundation governed?

By a volunteer board of directors representing the diversity of Switzerland County. Board members can serve up to two three-year terms.

Where does funding to operate the Foundation come from?

From several sources. The Foundation annually charges a 1.5% administrative contribution to endowments, an Administrative Endowment makes grants for operating costs, and the Foundation's current and former directors also contribute.

Are contributions to the Community Foundation tax-deductible?

Absolutely. The IRS has classified the Community Foundation of Switzerland County as a 501 (c) (3) public charity, so gifts qualify for the most generous tax (income, capital gains, and estate) benefits available.

Can I be specific about how my contribution is used?

Yes. Some donors know exactly where they want their contributions to go. In these instances the Community Foundation's responsibility is to ensure that the recipient organization is a legitimate non-profit entity with an active board that meets the standards of the Foundation.

May contributions be made anonymously?

Yes. All you have to do is inform the staff of your wishes and they will ensure that your name remains anonymous.

Who are the donors to the Community Foundation of Switzerland County?

Donors are people just like you. One need not be wealthy to make a difference. Working with the Community Foundation, you can have a lasting impact on the quality of life in Switzerland County right now and for years to come.

May I leave a bequest to the Community Foundation of Switzerland County in my will?

Most certainly. Community members are urged to consider a bequest for the benefit of the Switzerland County community through the Community Foundation.

What is an 'endowment'?

It is a permanent fund set up by an individual or organization through a written agreement between the donor and the Foundation. Gifts to the fund are invested. Investment income is used to make grants and scholarships. The original value of the fund is not spent. All of the Foundation's more than 100 endowment funds are pooled for investment purposes but each individual fund is accounted for separately.

What kinds of grants can be awarded from an endowment?

The Foundation is a very flexible tool for people to use and as long as a project, program, or organization is charitable, anything is possible. Founding donors establish how grants should be distributed from their endowment.

What does it cost to set up an endowment?

There are no start-up fees. An annual administration contribution of 1.5% from the fund is used to help with administrative expenses, including reporting annually to founding donors about their funds' financial activity.

What is the minimum amount needed to start an endowment?

An endowment must reach \$5,000 (\$10,000 for scholarships) before it can start awarding grants. However, an Acorn Fund can be established with \$1,000 as long as a donor commits to contributing \$500 or more annually until the fund does reach \$5,000. The fund will not pay out any grants until it reaches \$5,000 and that amount has been invested for one full fiscal year.

How are my gifts invested?

The Foundation's Investment Committee, with the assistance of an investment consulting firm, seeks to prudently maximize returns by investing in a balanced portfolio of stocks and bonds and diversifying over a number of asset categories. The Foundation tries to preserve the 'purchasing power' of the funds over time by reinvesting a portion of the investment returns back into the fund. That way the endowments keep pace with inflation.

How are the endowment grants determined?

The Foundation has adopted, along with hundreds of endowment managers in the country, a Total Return Policy. The policy has two goals: to maintain and increase the real value of the endowment and to smooth out the short-term roller coaster ride that inevitably results from investing in the marketplace. Depending on the current climate, the Foundation generally awards up to 4% of a fund's average market value over the preceding 20 quarters. New funds must be invested a full calendar year before they can make grants.

Why establish a fund with the Community Foundation instead of giving directly to a favorite charity?

A gift to the Community Foundation to support a favorite charity or cause is a permanent gift that will produce income forever. A donor who supports a particular charity with an annual gift can continue to support the charity forever by making a permanent gift to the Community Foundation for that charity during his/her lifetime or in his/her will.

Acorn Funds

These funds are under \$5,000 (\$10,000 for scholarships), but donors are set on a schedule to regularly add to the fund so that it reaches the \$5,000 (\$10,000 for scholarships) minimum in a reasonable timeframe. At the time the fund reaches the minimum, the fund will then become a permanent endowment based on the donor's wishes. The Fund will not award any grants until it reaches \$5,000 (\$10,000 for scholarships) and that amount has been invested for one full fiscal year.
